### SECTION 4. FIRST-AID MEASURES

#### 6.3 Methods and material for containment and cleaning up

Use a vacuum cleaner. If not possible, moisten dust with water before it is collected with shovel, broom or the like. Dust Deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air.

#### 7.1 Precautions for safe handling
